(Travel expenses, costumes, etc.) Local and out of town artists will be expected to attend an evening technical rehearsal (5/14 or 5/15 – local) (5/16/11 - out of town), dress rehearsal (5/17/12) and three performances (5/18/12 & 5/19/12).
- Moving Current is responsible for providing performance space and box office, programs, technical crew and all promotional needs relating to *NewGrounds*.
